

**FOSTER CARE AGREEMENT**

I, \_\_\_\_\_ voluntarily enter into this agreement to provide temporary care and custody and necessary sustenance as a foster caregiver for Willy's Kitty Angels Rescue, Inc. **My initials in the space provided confirm my consent to this agreement.**

- I agree to provide WKA access to my home and property for a home inspection before my application to foster is approved. \_\_\_\_\_
- I understand that I could be required to provide foster care to my foster animal for an extended period of time. I agree that the period covered by this agreement is the entire time during which I have custody of my foster animal. \_\_\_\_\_
- I agree that I am over 21 years of age. \_\_\_\_\_
- I agree to provide my foster animal with proper and routine veterinary care paid for by WKA, I agree to administer medications as prescribed by WKA vet. \_\_\_\_\_
- I understand that I am financially responsible for purchasing the specified brand of wet/dry cat food as described by WKA. \_\_\_\_\_
- I understand that WKA provides no guarantee as to the health of my foster animal, and that my foster animal may have significant medical needs, socialization problems, and may not be litter box trained. \_\_\_\_\_
- I will take all necessary precautions to prevent my foster animal from either impregnating another animal or becoming impregnated. In the event that such happens, I will alert the WKA immediately. \_\_\_\_\_
- I will not arrange or pay for, or otherwise cause, any elective veterinary procedure to be performed on my foster animal during the period covered by this agreement, without the express written consent of WKA. \_\_\_\_\_
- I understand that I may only have my foster animal temporarily. \_\_\_\_\_
- I agree that I am fostering this animal for WKA, and that I do not have any right of

ownership over my foster animal. I also agree to provide WKA access to my home and property to check on my foster animal, at any time that I am in possession of my foster animal. \_\_\_\_\_

- I agree to immediately return any foster animal in my care to WKA, at the request of the WKA director, at any time and for any reason. \_\_\_\_\_

- If I am planning to move at any time during the period covered by this agreement, I agree to contact WKA prior to my move, with new contact information. I understand that WKA has the right to request return of my foster animal based on such a change of residence, and agree that I will surrender my foster animal to WKA immediately upon request. \_\_\_\_\_

- I understand that, as long as I provide foster care to my foster animal to WKA's satisfaction, I will be given the first right of adoption of my foster animal, at such time as WKA decides to offer my foster animal for adoption. \_\_\_\_\_

- I will notify WKA immediately if my foster animal has an onset of illness of any kind. \_\_\_\_\_

- I will not let the foster animal outside for any reason. \_\_\_\_\_

- If at any point I can no longer, or do not want to continue to, provide care, food, and shelter for my foster animal, I agree to contact WKA and arrange for surrender and return of my foster animal back to WKA. \_\_\_\_\_

- I will not transfer possession or custody of my foster animal to any other person at any time. \_\_\_\_\_

- I understand that exposing cats to any kind of smoke increases the risk of lung irritation and potentially could result in lung cancer, therefore, I agree not to smoke in or around the foster animal. \_\_\_\_\_

- I agree to contact WKA with any and all questions or concerns about my foster animal or the fostering program, as well as with updated contact information. \_\_\_\_\_

- I agree that if I refuse to comply with any provision of this agreement, WKA has the right to terminate this agreement and also has the right to the immediate surrender and return of my foster animal and any other animals for whom I am providing foster care for WKA.

- I further consent to provide WKA with access to my premises if necessary to facilitate the return. \_\_\_\_\_

**Volunteer/Foster Release and Liability Waiver**

I \_\_\_\_\_ understand that Willy’s Kitty Angels Rescue., Inc., and its representatives have limited information regarding the temperament and habits of the animals under its care and ownership. As a Volunteer/Foster for Willy’s Kitty Angels Rescue., Inc., I agree to take all reasonable precautions (through the use of crates, supervision and common sense) to ensure that the animal does not get out of the house, become a nuisance, destroy property, injure or be injured by another animal, be injured by any person, or injure me or another person. By becoming a Volunteer/Foster, I hereby waive, release, discharge and hold harmless Willy’s Kitty Angels Rescue., Inc. and its agents, employees, directors, representatives and other volunteers charged or chargeable with liability, from any and all claims, damages, costs, expenses, loss of services, actions, and causes of actions, whether known or unknown, belonging to me, my heirs, agents and assigns, due to any action or occurrence or damage which arises in connection with my volunteer activities, including, but not limited to cat bites to me or members of my household by a Willy’s Kitty Angels Rescue., Inc. animal.

I understand that once I take a Willy’s Kitty Angels Rescue., Inc. cat in for foster that I am making a commitment to the animal until it is placed into an adoptive home. I will give Willy’s Kitty Angels Rescue., Inc. proper notice should I not be able to continue fostering so that further suitable placement can be found for the animal. If I need the cat immediately removed from my care through no fault of the cat (aggression, biting, etc.), I agree that I will be financially responsible for boarding the cat until another suitable placement can be found. Furthermore, I agree to indemnify Willy’s Kitty Angels Rescue., Inc. for any and all expenses, including court costs and reasonable attorney fees, incurred in enforcing the terms and provisions of this agreement.

I the UNDERSIGNED hereby acknowledges having read this Waiver and does hereby agree to abide to its terms as set forth above.
